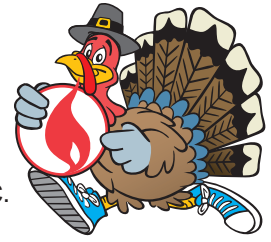

ADDITIONAL MERCHANT OPPORTUNITIES

In addition to the opportunities for direct sponsorship, we have the following available:

- **Prizes** can be donated for our drawing. ALL registered runners are eligible. The drawing is based on the issued race numbers. Items/coupons/gift certificates worth \$5 to \$25 are appropriate.
- **Vendor Display** of products or services. Vendor may have an attended table, not to exceed 8 (eight) feet in length, to display literature and/or discuss their business.
- **Vendor Product/Service Provision.** A merchant may set up and distribute appropriate products or provide a service, without charge, to those present. Space used must not exceed 8" X 8".

Please note that there is NOT space available INDOORS for vendors to set up.

All displays will be outdoors, in the parking lot.

The walkway and entrance must be kept clear for runners.

Fees: The fee is \$50.00 for a "Vendor Display"

The fee is \$20.00 for "Product or Service" that is minimal in amount.

The fee is \$ NONE for "Product or Service" that is given in quantity for most attendees.

The following contract is required:

You agree to have a display outside, on the property of the American Legion Post 360 in Halesite, NY.

It is understood that you will not block the passage of runners between the start/finish and the entrance to the building.

Further, you will undertake to remove all you items from the grounds no later than 11:00 AM on that date.

The Townwide Fund is not responsible to supply you with any equipment to set up, maintain or dismantle your display.

You agree to have at least one person in attendance throughout the presence of your display.

In no way is this contract to be construed as a testimony to the efficacy, or lack thereof, of any of the programs, products or services offered by your business.

Finally, in consideration of the permission to display or distribute information or product, you will donate the sum of _____ dollars to the Townwide Fund of Huntington, Inc.
